SUBJECT: Establish Nonrecurring Cost (NC) Charge - AN/AYK-29(V)1 Distributed Targeting System (DTS) and AN/AYK-29(V)1 Distributed Targeting Processor (DTP), DSCA Policy Memo 12-26

The attached Finding, signed by the Director, Defense Security Cooperation Agency, approves a nonrecurring cost (NC) recoupment pro rata charge for the sale, coproduction, or licensed production of the items shown on the Finding table.
