SUBJECT: Assignment of Program Code "H8" to track Fiscal Year (FY) 2013 Funds Provided for the Section 1206 Global Train and Equip Program, DSCA Policy 12-52 [SAMM E-Change 211]

Effective immediately, Program Code "H8" is assigned to track FY13 funds provided for Section 1206 Programs authorized under the National Defense Authorizations Act for Fiscal Year 2006 (Public Law 109-163), as amended. Management and execution of FY13 Section 1206 (H8) programs will comply with guidance provided in the Security Assistance Management Manual (SAMM), Chapter 15.

The SAMM Table C4.T2, Country and International Organization Codes and FMS Eligibility, is updated as follows:

Appropriations available for H8 Letters of Offer and Acceptance (LOAs) are recorded in the SAMM, Table C15.T2, Appropriation Authority column, and will be cited on each H8 LOA in the Funds Expiration, Purpose, Availability, and Amount note. FY13 funds expire for new obligations in compliance with the terms of the appropriation authority. For example, funds provided under the FY13 Continuing Appropriations Resolution (CR), P.L. 112-175, expire for new obligation on March 27, 2013.

Instructions for preparation of H8 LOA documents are found in the SAMM, Table C15.T5. Standard notes applicable to BPC programs are found in the SAMM, Appendix 6, LOA Notes Listing. Government and contract services under a Section 1206 Program are provided with "cross fiscal year authority" as described in the SAMM, Chapter 15, C15.3.4.3. Funding associated with H8 LOAs will be fully expended, and H8 cases will be reconciled and closed on or before July 31, 2018.
