SUBJECT: Assignment of Program Code "2F" to track Fiscal Year (FY) 2017/18 Counter-ISIL Train and Equip Fund (CTEF) for Syria, DSCA Policy 17-24 [SAMM E-Change 359]

Effective immediately, Program Code "2F" is assigned to track FY 2017/18 Counter-ISIL Train and Equip Fund (CTEF) for Syria specific programs. Funds are provided by Division C of the Consolidated Appropriations Act, 2017 and are available for obligation until September 30, 2018. Management and execution of FY 2017 CTEF Syria specific programs will comply with guidance provided in the Security Assistance Management Manual (SAMM), Chapter 15.
