SUBJECT: Assignment of Program Codes "QG" to Track Fiscal Year (FY) 2019 Overseas
Contingency Operations Funds Provided for the Ukraine Security Assistance
Initiative (USAI), DSCA Policy 18-60 [SAMM E-Change 409]

Effective immediately, Program Code "QG" is assigned to track FY 2019 Overseas Contingency Operations (OCO) funds provided to conduct or support programs executed under the USAI authority provided by Section 1250 of the National Defense Authorization Act for FY 2016 (P.L. 114-92), as amended. Section 9013 of Title VIII, Division A of the Department of Defense and Labor, Health and Human Services, and Education Appropriations Act, 2019 and Continuing Appropriations Act, 2019 (P.L. 115-245) makes OCO funds available for these programs until September 30, 2019.

Management and execution of FY 2019 USAI "QG" programs will comply with guidance provided in the Security Assistance Management Manual (SAMM), Chapter 15.

The SAMM Table C4.T2B, Security Cooperation (SC) Customer and Regional Codes and FMS Eligibility, is updated as follows:


