In accordance with references (a) and (b), the United States-Jordan Defense Cooperation Act of 2015 (Public Law (P.L.) 114-124), which became effective on February 18, 2016, required that during a three-year period beginning from the date of enactment, Jordan would be treated as if it were included with the NATO+five countries with regard to a variety of requirements of the AECA. This authority expires February 18, 2019.

Effective February 18, 2019, Jordan's temporary NATO +five status will no longer apply unless it is renewed by the U.S. Congress.
